Guidelines for Installation and Operation of Electric Vehicle Charging Infrastructure-2024,- in Urban Areas: By FY 2030, there will be at least one charging station within a 1 km x 1 km grid in urban areas as notified by respective state governments. "Accordingly, 300 EV charging stations shall be developed in Faridabad city

1. HSVP Faridabad is developing a bus depot with EV charging facilities, having a capacity of 100 buses, which is scheduled to be completed by the end of September 2026.

2. It is submitted that approximately 40% of the area of Faridabad (Greater Faridabad) city is not densely populated. In these areas, many residents have already installed their own EV charging devices within their premises. Considering the demand and viability, under the National Clean Air Program, on 23-02-2024, the Municipal Corporation Faridabad (MCF) signed a Memorandum of Understanding (MoU) with Convergence Energy Services Limited (CESL), a wholly owned subsidiary of EESL (a joint venture of PSUs under the Government of India), for the development of an extensive network of public EV charging stations and Battery Swapping Station (BSS) infrastructure across the city.

The MoU adhered to the standard guidelines issued by the Ministry of Power, Government of India, and was signed for a tenure of ten years. During the joint survey conducted by MCF and CESL, 25 suitable locations were identified for the installation of EV charging stations in Faridabad city. However, during the negotiations on revenue sharing, CESL was not willing to increase the price, and therefore the said MoU has since been cancelled.

Municipal Corporation, Faridabad is in the process of publishing an EoI to invite interested stakeholders to present and demonstrate the latest technologies in EV charging and battery swapping systems. Following this, MCF will select a concessionaire for setting up EV charging stations in Faridabad city through tendering process, for which 25 locations have already been identified. Last mile connectivity:

At present, Faridabad city does not have a structured mechanism to ensure effective last-mile connectivity. Many residents rely on their own private vehicles for convenience, while those using public transport systems such as the Metro and city buses often depend on shared autos, e-rickshaws, or other local modes of transport to reach their final destinations. This lack of organized last-mile solutions creates inefficiencies, increases travel time, and contributes to traffic congestion.

Recognizing this challenge, the Municipal Corporation of Faridabad is planning to undertake a comprehensive survey to develop a suitable plan of action for last-mile connectivity. A professional agency will be appointed through a transparent tendering process to carry out this survey. The agency will be responsible for assessing the current situation, identifying gaps, and recommending practical solutions that integrate seamlessly with existing public transport infrastructure.

In addition to last-mile connectivity, the survey will also cover other critical aspects of urban mobility and infrastructure. These include:

- Assessing the requirement for EV charging stations across the city.
- Evaluating the feasibility of battery swapping systems to support electric vehicles.
- Conducting a detailed study of traffic congestion patterns and proposing measures for improvement.

The survey outcomes will provide the Municipal Corporation with actionable insights to design a roadmap for sustainable, efficient, and eco-friendly urban transport. Clear timelines will be established for each stage, including agency selection, survey execution, data analysis, and submission of the final action plan, ensuring accountability and timely implementation.

In 1st phase MCF has published Tender No-2025_HRY_469621_1for selection of bidder for Design, Development, Implementation, Operation and Maintenance of smart Parking Solution at 54 locations with estimate parking capacity of Approx. 8500 vehicles and in 2nd phase MCF shall publish the tender for remaining 34 location with approx. 3000 vehicle parking capacity which tender drafting under process.
2. MCF has published the tender No-2025_HRY_478707_1for Project Development and Management Consultancy (PDMC) Services for Preparation of DPR and supervision Services for Development of Multi-Level Parking Facility (MLPF) Near Fawda Singh Chowk, Faridabad by Municipal Corporation, Faridabad where selection process under progress and work order shall be issued to consultant before 31-12-2025 for DPR work. Total parking space shall be 300-350 vehicles.
3. An existing multilevel parking facility is situated on the Sector 17/18 dividing road near Marengo Asia Hospital. The construction work has been completed, and only the Fire No Objection Certificate is pending. The total project cost is Rs 16.73 crore. The facility covers an area of 400 square metres and comprises a G+5 structure. The likely date of commencement of operations is 30.06.2026.

- MCF had established a C&D Waste Processing Plant at Riwazpur for which contract was awarded to M/s RAW2Road. & further due to non- performance the contract was terminated w.e.f. May 4, 2025, due to non-performance of the agency.
- MCF has identified five tentative Construction & Demolition (C&D) waste collection sites, one in each Division, for the collection and temporary storage of C&D waste. These sites will serve as interim facilities for time-gap management until the commissioning of the new C&D waste processing plant. Once operational, all collected waste will be processed in accordance with the C&D Waste Management Guidelines. The five disposal locations are as follows:
 - Badhkal and NIT – Behind Nursery Bagh Boosting Station, near Railway line, NIT-5 Area

Note: At present, Faridabad city does not have a Construction & Demolition (C&D) waste processing plant. Municipal Corporation, Faridabad is planning to establish a C&D waste processing facility, which is expected to be completed by October 2026. As per the plan, the operation of the facility will be entrusted to contractors selected through a transparent tendering process. The appointed agency will be responsible for the sale of recycled products in the market.

MCF will procure finished goods and recycled materials, as required, for use in municipal and government contracts. Such procurement will be subject to strict quality control and will be made available at a 15% discount on the prevailing rates of the Haryana Schedule of Rates (HSR). Furthermore, recycled materials will be integrated into MCF’s procurement policy for infrastructure projects to promote sustainable construction practices.

MCF shall also encourage private players engaged in the construction of roads and other infrastructure projects to utilize recycled materials. The Corporation will promote the purchase of such materials from the upcoming C&D waste processing plant, thereby ensuring that the model of C&D waste management remains self-sustainable
