

Actions / documents required for consideration of resumption of entities against which closure directions are issued by CAQM

A. Industrial Sector

1. Cases where the Unit was found operating in gross violation of the Directions of the Commission

(i) An Undertaking in the form of Affidavit (as per Annexure-A) of compliance of Closure Directions, that corrective and preventive measures have been taken, EC has been deposited and that the Directions and statutes will be complied with in future.

(ii) Supporting documents / actions confirming that the violations have been resolved / rectified, wherever required.

(iii) Documentary proof of imposition and deposition of EC in the SPCBs/DPCC account by the entity, including details of online transfer of the EC charges levied by SPCB / DPCC through RTGS / NEFT etc. (in case of deposition of EC through offline modes viz. DD, Cheque etc., a confirmation from the concerned PCB / DPCC to the effect that the EC charges have been deposited in their respective accounts shall also be mandatorily required).

2. Unit was found operating without CTE and/or CTO

(i) An Undertaking in the form of Affidavit (As per Annexure-A) of compliance of Closure Directions, that corrective and preventive measures have been taken and that the Directions and statutes will be complied with in future.

(ii) Copy of valid CTE and / or CTO issued by the concerned SPCB/ DPCC.

3. Unit was found operating DG sets when its use was prohibited and/or not maintaining proper records including logbook

4. Units with heavy visible emissions (source/ fugitive)/ violating consent conditions/ non-operation of Air Pollution Control Device

(ii) Supporting documents / actions confirming that the violations have been resolved / rectified, wherever required.

(iii) Documentary proof of imposition and deposition of EC in the SPCBs/DPCC account by the entity, including details of online transfer of the EC charges levied by SPCB / DPCC through RTGS / NEFT etc. (in case of deposition of EC through offline modes viz. B. Construction and Demolition Projects

1. C&D related activities were going on at the site in violation of Commission's directions and other relevant rules and regulations

(i) An Undertaking in the form of Affidavit (As per Annexure B) of compliance of Closure Directions, corrective and preventive measures have been taken, EC has been deposited and that the Directions and statutes will be complied with, in future.

(ii) Supporting documents confirming that the violations have been resolved / rectified, wherever required.

(iii) Documentary proof of imposition and deposition of EC in the SPCBs/DPCC account by the entity, including details of online transfer of the EC charges levied by SPCB / DPCC through RTGS / NEFT etc. (in case of deposition of EC through offline modes viz. EC charges have been deposited in their respective accounts shall also be mandatorily required).

2. C&D related activities were going on at the site in violation of Commission's directions and other relevant rules and regulations and unit was also found operating DG sets in violation of CAQM directions.
