Chapter – 1

INTRODUCTION

The Commission for Air Quality Management in NCR and Adjoining Areas has been established under an Act of Parliament for better coordination, research, identification and resolution of problems surrounding the air quality index and for matters connected therewith or incidental thereto in Delhi NCR and Adjoining Areas.

Chapter-2

GENERAL INSTRUCTIONS FOR BIDDERS

1. The EOI requires submission of a detailed proposal for advertisement, calling online applications, settling grievances of applicants online, having/hiring exam centres for conducting online written tests in Delhi NCR and providing names of meritorious candidates in the ratio of 1:5 or more for each post as per decision of CAQM for final selection.
2. Details of posts and number of posts to be filled up, shall be conveyed at the time of calling financial bids from the empaneled government agencies.
3. Pre Eoi meeting will be held on 09.01.2026 at 11.00 A.M. in CAQM office, before the end date of EOI Submission to address the queries related to the requirement. Further clarifications (if any) regarding any aspect of the EOI (if any) will be provided to the Bidders consequently. Only the queries received on or before the date prior to the Pre-EOI meeting will be entertained and answered. All such queries / clarifications, together with all details on which the clarification had been sought, will be uploaded on the GeM portal and on the CAQM Website.

The representatives of the interested parties (restricted to two persons) may attend the Pre EOI Meeting. In case of non-receipt of any query in advance, the meeting will not be conducted.

4. Eligibility Criteria: All the interested Government / PSU/ Autonomous organizations must meet the criteria mentioned at Annexure-T-I. The bidding parties meeting the criteria must enclose their supporting documents along with their proposal on GeM Portal (<https://gem.gov.in>).
5. CAQM invites detailed proposal from Govt./PSU/ Autonomous organizations in single packet through GeM to judge the eligibility of the organizations and empanelment them for inviting bids at a later date.

6. The EOI document can be downloaded from the GeM Portal (URL:<https://gem.gov.in>). Besides, EOI document can also be downloaded from the CAQM website (<https://www.caqm.nic.in>). Prospective Bidders who have not enrolled/registered with the Gem portal shall have to enroll/register themselves before participating through the website of GeM (URL:<https://gem.gov.in>).

7. Period of Validity of EOI: The proposals shall remain valid till 180 days from the date of opening which can be extended further.

8. Evaluation & empanelment:

After the opening of the proposal, the CAQM will examine the credentials of the agencies, based on the submitted documents as per the eligibility criteria detailed in Annexure T-I and other eligibility criteria as mentioned in GeM Bid Document to shortlist the agencies for calling limited tender at a later date.

9. The Competent Authority of CAQM is not bound to accept the proposal if any technical discrepancies are found in the EOI. However, it reserves the right to accept/reject the proposal, and the decision of the Authority in this regard shall be final and binding on the Bidder.

10. Mere submission of proposal will not be considered as a qualification of the bidder in regular tender inquiry to be published later.

11. Resolution of Disputes: If any dispute arises between the parties hereto during the subsistence or thereafter, in connection with the validity, interpretation, implementation or breach of any provision of the proposal, both Parties hereto shall endeavor to settle such dispute amicably.
