



In exercise of the powers conferred under Sub-section (4) of Section 10 of the Commission for Air Quality Management in National Capital Region and Adjoining Areas Act, 2021 read with the provisions of the Commission for Air Quality Management in National Capital Region and Adjoining Areas (Conduct of Business and Conditions and Limitations in Delegation of Powers of Commission) Regulations, 2021 subsequent to the decision(s) taken by the Commission in its meeting dated 17.10.2025, the Commission, hereby omits the Sub-clauses (iii), (iv) and (v) of Clause 2 of the Order bearing No. R-11011/1/2021-Estt./1069-1074 dated 07.10.2021.

ORDER

Subject: Delegations of Powers of the Commission-reg.

The Powers and Functions of the Commission are primarily enumerated under Chapter III, from Section 12 to Section 15, of the Commission for Air Quality Management in National Capital Region and Adjoining Areas Act 2021(No.29 of 2021), though other Sections also cast responsibilities on the Commission.

In exercise of powers conferred under Sub-section (4) of Section 10 of Act, 2021 and "The Commission for Air Quality Management in National Capital Region and Adjoining Areas (Conduct of Business and conditions and Limitations in Delegation of Powers of the Commission) Regulations, 2021" notified vide F. No. R-11011/1/2021-Estt. dated 17th September, 2021, pursuant to the decision taken by the Commission, the powers of the Commission shall be exercised by the Commission or as delegated to the Chairperson, Full-time Member, Member Secretary or Sub-Committees as provided under the Act 2021 as under:

1. Powers to be exercised only by the Commission:

- i. To issue directions to abate air pollution and to regulate or prohibit activities that are likely to cause or increase air pollution in the National Capital Region and Adjoining Areas;
- ii. To lay down parameters for the quality of air in its various aspects and to lay down parameters for emission or discharge of environmental pollutants from various sources whatsoever that have implications on air quality in the region;
- iii. To restrict areas in which any industries, operations or processes or class of industries, operations or processes that have implications on air quality in the region, subject to certain safeguards;
- iv. To make Regulations;

- v. To take note of and issue further directions, if any, on anything done or action taken or recommendation made by the Sub-Committees constituted under the Act;
Provided that the Chairperson may take appropriate decisions on issues of urgent nature warranting immediate action and the same shall be placed before the Commission for ratification.


2. Delegation of powers and functions of the Commission:

- i. The Commission, for the purpose of smooth and effective functioning of the Commission and for the purpose of protecting and improving the quality of the air in the National Capital Region and Adjoining Areas, delegates all its powers and functions to the various authorities including the Chairperson and the Member Secretary, except those indicated in para 1 above, as specified in the **Annexure**;
- ii. Irrespective of the fact that, some of the powers and functions of the Commission are delegated to various authorities, the Commission shall, at all times, have authority, either on application made by a person or *suo-motu*, to review, revoke, revise, amend, alter or otherwise change any order made or action taken by any authority/ Officer of the Commission, if the Commission considers the same to be appropriate in public interest;
- iii. All powers of the Commission relating to Establishment, Administration, Finance, Budget, Accounts, Vigilance and other miscellaneous functions shall be exercised by the Chairperson or the Chairperson may delegate any of the powers entrusted to him to the Member Secretary of the Commission, as deemed fit and necessary, in discharge of the functions of the Commission;
- iv. The Chairperson may engage such numbers of experts and professionals, having special knowledge and experience in disciplines related to the functioning of Commission, as it deems necessary to assist the Commission in the discharge of its functions under the Act. The terms and conditions of engagement of experts and professionals would be decided by the Chairperson;
- v. The Member Secretary may further delegate the powers, vested with him, to the officers of the Commission, with the approval of the Chairperson, in discharge of functions under the Act;
- vi. The respective Sub-Committees, constituted under Section 11 of the Act, may take appropriate decisions, on the subjects for which the Sub-Committees have been constituted. However, any

decision taken or recommendation made by the Sub-Committees shall be brought before the Commission in its subsequent meeting;

- vii. The Chairperson and the Member Secretary shall have power to take decisions on the subjects which are not specifically mentioned herewith but are necessary for the Commission in the discharge of its functions.
